SUMMARY:

- I have twenty-three years of experience as a forensic and licensed clinical psychologist with expertise in psychological trauma and twenty-nine years in the mental health field, working with thousands of trauma survivors, many of whom experienced physical or sexual abuse as adults or as children.
- I maintain a private practice focused on the treatment of psychological trauma survivors.
- I wrote both a master's thesis and a doctoral dissertation on the impact and treatment of the trauma of sexual abuse.
- I have been qualified 143 times in 42 counties, 14 states, and 2 countries (the United States and Japan) as an expert in trauma-related forensic matters (primarily sexual assault or intimate partner violence); I have testified in criminal and civil cases and as an expert in psychological trauma in County and District courts for both the prosecution and defense.
- I consult on civil (tort) interpersonal trauma cases as a damages and counterintuitive victim behavior expert.
- I have consulted with civilian, military, and tort attorneys on well over 500 sexual assault, child sexual assault, intimate partner, stalking, and interpersonal violence cases.
